The Issuer issued an aggregate of 3,579,922 Shares to the Acquiror from treasury pursuant to the following transactions:

- a) The Acquiror was issued 375,000 Shares pursuant to a non-brokered private placement at a price of \$0.02 per Share.
- b) The Acquiror was issued 238,820 Shares pursuant to a debt settlement agreement, which converted the Acquiror’s convertible debt to equity at a price of \$0.05 per Share.
- c) The Acquiror was issued 2,966,102 Shares pursuant to a convertible note, which converted the Acquiror’s convertible debt to equity at a price of \$0.0118 per Share.

The Acquiror acquired Shares pursuant to the following transactions which completed on December 22, 2017:

- a) The Acquiror was issued 375,000 Shares pursuant to a non-brokered private placement at a price of \$0.02 per Share.

b) The Acquiror was issued 238,820 Shares pursuant to a debt settlement agreement, which converted the Acquiror's convertible debt to equity at a price of \$0.05 per Share.

c) The Acquiror was issued 2,966,102 Shares pursuant to a convertible note, which converted the Acquiror's convertible debt to equity at a price of \$0.0118 per Share.

Immediately following the acquisition of the securities detailed above, the Acquiror held or controlled an aggregate of 3,579,922 Shares and 250,000 stock options of the Issuer, each exercisable to acquire one Share. These securities represent 29.6% of the issued and outstanding shares of the Issuer calculated on a fully-diluted basis.

The Acquiror acquired ownership and control of the Shares that triggered the requirement to file this report.

The Acquiror directly owns and controls 3,579,922 Shares and 250,000 stock options of the Issuer, each exercisable to acquire one Share.

The 3,579,922 Shares comprised of an aggregate of \$54,441 composed of the following:

- a) 375,000 Shares at a price of \$0.02 for a total of \$7,500, pursuant to a private placement;
- b) 2,966,102 Shares at a price of \$0.0118 for a total of \$35,000, pursuant to a convertible note; and
- c) 238,820 Shares at a price of \$0.05 for a total of \$11,941, pursuant to a debt settlement agreement.
