On January 4, 2018, the Company closed a non-brokered private placement of 41,666,666 Shares at \$0.06 per Share. In addition, the Company issued 3,749,999 Finder's Warrants, which entitles the holder to purchase one Share at a price of \$0.06 per Share, expiring 24 months from the Finder's Warrant issuance date.

As of January 4, 2018, the Company had 54,230,320 Shares issued and outstanding. The Acquiror, who holds 3,579,922 Shares and previously held over 10% of the Company's issued and outstanding Shares, has now fallen under 10%.

These securities represent 6.5% of the issued and outstanding shares of the Issuer calculated on a fully-diluted basis.
