**CENTURY FINANCIAL ANNOUNCES RESULTS OF ANNUAL AND SPECIAL
MEETING OF SHAREHOLDERS**

TORONTO, ON, March 19, 2018 – Century Financial Capital Group Inc. (“**Century Financial**” or the “**Company**”) reports the results of its Annual and Special Meeting of Shareholders (the “**Meeting**”) held on March 15, 2018, in Toronto, Ontario. At the Meeting, all matters presented for approval at the Meeting by management were duly approved and authorized, including:

- the re-election of Yaron Conforti, Harry Bregman and Gord Wilton as directors of the Company to hold office until the completion of the Company’s proposed business combination with FV Pharma Inc. by way of three-cornered amalgamation (the “**Proposed Transaction**”);
- the increase of the number of directors of the Company from three directors to five directors and the election of Yaron Conforti, Harry Bregman, Thomas Fairfull, Zeeshan Saeed and Donal Carroll as directors of the Company, conditional upon, and effective as of the completion of the Proposed Transaction;
- the name change from “Century Financial Capital Group Inc.” to “Cannabis ConneXion Corp.” conditional upon, and effective as of the completion of the Proposed Transaction;
- the amendments to the Company’s current articles to be completed in connection with the Proposed Transaction, as set out in the Company’s management information circular dated as at February 9, 2018;
- the appointment of Dale Matheson Carr-Hilton Labonte LLP as auditor of the Company for the ensuing year;
- the Company’s stock option plan; and
- the proposed change of the Company’s registered and head office to a new address in connection with the Proposed Transaction.
