On November 27, 2018, the Company completed a reverse takeover transaction (“**RTO Transaction**”) with Dixie Brands, Inc. Pursuant to the RTO Transaction, the Company re-designate its existing common shares as Subordinate Voting Shares, underwent a 4-for-1 share consolidation, and issued a total of 118,137,967 Shares. Prior to RTO Transaction, the Acquiror held, directly or indirectly, or exercises control or direction over an aggregate of 4,100,768 common shares, representing 15.44% of the issued and outstanding common shares on a non-diluted basis out of 26,567,234 then issued and outstanding common shares. Following the RTO Transaction, the Acquiror holds 1,025,192 Shares (on a post-consolidation basis) out of 124,778,269 issued and outstanding Shares (on a post-consolidation basis). This represents a decrease in the Acquiror’s security holding percentage to 0.82%.
