The Creditor and the Issuer entered into a debt conversion agreement (the "**Debt Conversion Agreement**") on February 20, 2018, pursuant to which the Creditor agreed to accept 20,868,350 Common Shares at a deemed issued price of \$0.005 per Common Share, in full settlement of \$104,341.75 of indebtedness owing to the Creditor by the Issuer (the "**Transaction**"). The Transaction closed on March 14, 2018.

The Creditor received 20,868,350 Common Shares through the settlement of an aggregate of \$104,341.75 of indebtedness at a price of \$0.005 per Common Share.

The Creditor acquired 20,868,350 Common Shares of the Issuer at a price of \$0.005 per Common Share pursuant to a Debt Conversion Agreement for aggregate cash consideration of \$104,341.75.

The 20,868,350 Common Shares were acquired through the settlement of an aggregate of \$104,341.75 of indebtedness owed to the Creditor.
