The Creditor and the Issuer entered into a debt conversion agreement (the “**Debt Conversion Agreement**”) on February 20, 2018, pursuant to which the Creditor agreed to accept 30,871,342 Common Shares at a deemed issued price of \$0.005 per Common Share, in full settlement of \$154,356.71 of indebtedness owing to the Creditor by the Issuer (the “**Transaction**”). The Transaction closed on March 14, 2018.

The Creditor acquired 30,871,342 Common Shares of the Issuer, representing approximately 16.21% of the issued and outstanding Common Shares of the Issuer respectively.

The Creditor received 30,871,342 Common Shares through the settlement of an aggregate of \$154,356.71 of indebtedness at a price of \$0.005 per Common Share.

The Creditor acquired 30,871,342 Common Shares of the Issuer at a price of \$0.005 per Common Share pursuant to a Debt Conversion Agreement for aggregate cash consideration of \$154,356.71.

The 30,871,342 Common Shares were acquired through the settlement of an aggregate of \$154,356.71 of indebtedness owed to the Creditor.

The securities were acquired for investment purposes. The Creditor currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Issuer's business and financial condition and/or other relevant factors, the Creditor may develop such plans or intentions in the future.
