Targa Electronic Systems Inc., a wholly-owned subsidiary of Targa Group Inc., owns 9,000 class A preferred shares of Plaintree Systems Inc. and David Watson and Nora Watson own 5,203.75 and 4,121.25 class A preferred shares of Plaintree Systems Inc., respectively.


