Digicann Ventures Announces Agreement to Extend Maturity Date for Convertible Debentures

Vancouver, British Columbia / March 11, 2025 (Globe Newswire) – Digicann Ventures Ltd. ("Digicann" or the "Company") (CSE: DCNN) (OTCPK: AGFAD), a company focused on opportunities within and outside of the cannabis industry, announces that it has entered into an agreement with holders of the Company's 10.00% Senior Unsecured Convertible Debentures (the "Debentures") to amend the Debentures to extend the maturity date for an additional twelve months from March 12, 2025 to March 12, 2026.

The Company has satisfied the aggregate accrued interest on the Debentures that is due on March 12, 2025 by the issuance of 1,000,000 common shares in the capital of the Company on a pro rata basis to the holders of the Debentures. As a result, the total number of common shares issued and outstanding as of the date of this news release is 23,055,294.

On April 17, 2024, the Company announced an agreement to amend the Debentures to extend the maturity date for an additional twelve months from March 12, 2024 to March 12, 2025.
