On November 19, 2021, pursuant to a private placement of Units Otsig acquired ownership of 800,000 Units at a price of \$0.05 per Unit. Each Warrant comprising part of the Unit entitles the holder to acquire one Share at a price of \$0.10 per Share until two years after the issuance of the Warrant.

**Item 3 – Interest in Securities of the Reporting Issuer**

**3.1 State the designation and number or principal amount of securities acquired or disposed of that triggered the requirement to file the report and the change in the acquiror’s securityholding percentage in the class of securities.**

Otsig acquired 800,000 Units, each unit comprising one Share and one warrant to acquire one Share at a price of \$0.10 per Share until two years after the issuance of the Warrant. Otsig’s percentage ownership of Shares of the Issuer was reduced from 13% to 10.25% of the issued and outstanding Shares on a non-diluted basis, and was approximately 13.6% on a partially diluted basis.

Otsig acquired direct ownership of the Units and Shares. See Item 2.2.

Prior to the acquisition of Shares pursuant to the private placements, Otsig held 5,628,000 Shares (13% of the issued and outstanding Shares), and immediately following the private placements, Otsig held 6,428,000 Shares (10.25% of the issued and outstanding Shares).

Otsig acquired the Units as part of private placements that the Company closed on November 19, 2021. The Units and Shares were acquired for long term investment purposes. Otsig has been and continues to be a supporter of the Issuer. In the future and depending on market conditions and/or other relevant factors, Otsig may acquire additional securities of the Issuer, including on the open market or through private acquisitions, or sell the securities on the open market or through private transactions. Otsig has no plans or future intentions that relate to or would result in the matters listed in clauses (a) through (k) of this Item 5.
