Mistango has a head office at 4 Al Wende Avenue, P.O. Box 546, Kirkland Lake, Ontario P2N 3J5.

The transaction that triggered the requirement to file this report was the acquisition by Orefinders Resources Inc. ("**Orefinders**") of 11,850,000 common shares of Mistango (the "**Shares**"), representing approximately 31.1% of the issued and outstanding shares of Mistango, pursuant to a definitive securities exchange agreement dated effective May 3, 2019 between Osisko Gold Royalties Ltd ("**Osisko**") and Orefinders (the "**Transaction**"). In consideration for the acquisition of the Shares, Orefinders issued an aggregate of 5,000,000 common shares in the capital of Orefinders (the "**OF Shares**") to Osisko, with a deemed value of \$250,000 based on a price of \$0.05 per OF Share.
