The transaction that triggered the requirement to file this report was the acquisition by Orefinders Resources Inc. ("Orefinders") of 11,850,000 common shares of Mistango (the "Shares"), representing approximately 31.1% of the issued and outstanding shares of Mistango, pursuant to a definitive securities exchange agreement dated effective May 3, 2019 between Osisko Gold Royalties Ltd ("Osisko") and Orefinders (the "Transaction"). In consideration for the acquisition of the Shares, Orefinders issued an aggregate of 5,000,000 common shares in the capital of Orefinders (the "OF Shares") to Osisko, with a deemed value of \$250,000 based on a price of \$0.05 per OF Share.
