On February 28, 2020, 2176423 Ontario acquired (the "Acquisition") ownership of 15,384,616 Units of the Corporation at a price of \$0.065 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.08 per Share until February 28, 2022. The Units were purchased on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
