On May 22, 2020, Eric Sprott acquired (the “Acquisition”) ownership of 5,454,546 Units of the Corporation at a price of \$0.275 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one-half Share at a price of \$0.35 per Share until May 22, 2022. The Units were purchased on a private placement basis.

The Acquisition results in an increase in holdings of approximately 3.8% of the outstanding Shares on a partially diluted basis from what was reported in the last early warning report. See items 2.2 and 3.4.

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned or controlled 15,384,616 Shares and 15,384,616 Warrants, representing approximately 14.8% of the issued and outstanding Shares on a non-diluted basis, and approximately 25.8% on a partially diluted basis assuming exercise of the Warrants.

After giving effect to the Acquisition, Sprott beneficially owns and controls 20,839,162 Shares and 18,111,889 Warrants, representing approximately 18.4% of the issued and outstanding Shares on a non-diluted basis, and approximately 29.6% on a partially diluted basis assuming exercise of the Warrants.

The Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

Item 6 – Agreements, Arrangements, Commitments or Understandings With Respect to Securities of the Reporting Issuer
