On May 22, 2022, a total of 2,727,273 Warrants with an exercise price of \$0.35 per common share of the Corporation ("**Share**") held by Eric Sprott expired unexercised, resulting in Mr. Sprott's beneficial ownership of the Corporation to decrease by approximately 2.0% on a partially diluted basis since the date of the last early warning report.
