The requirement to file this report was triggered on November 22, 2021 as a result of the Acquiror acquiring investment power over an aggregate of 6,050,000 Common Shares held by multiple shareholders of the Company via contractual arrangement. As a result, the Acquiror acquired control and direction over more than 10% of the issued and outstanding Common Shares on a non-diluted basis.

The aggregate 8,898,000 Common Shares now controlled and directed by the Acquiror represents approximately 12.04% of the issued and outstanding Common Shares on a non-diluted basis.
