The requirement this report was triggered on February 3, 2022, when SOL Global disposed of an aggregate of 1,300,000 Common Shares through the facilities of the CSE (the "**Transaction**"). As a result of the Transaction, SOL Global now owns less than 10% of the issued and outstanding Common Shares on a partially diluted basis. Accordingly, SOL Global is no longer required to file early warning reports pursuant to the requirements of National Instrument 62-103 - *The Early Warning System and Related Take-Over Bid and Insider Reporting Issues*, unless SOL Global's beneficial ownership or control of the Common Shares again increases above 10% of the issued and outstanding Common Shares.
