The Acquiror, through one of his private companies, has acquired 700,000 common shares of the Issuer at the price of \$0.05 through the facilities of the CSE.

The Acquiror acquired 700,000 common shares of the Issuer representing approximately 10% of the issued and outstanding common shares of Issuer.

The Acquiror has ownership and control of 2,616,220 common shares of the Issuer representing approximately 37% of the Issuer’s issued and outstanding common shares, which triggered the requirement to file this report.
