**Item 1.                    Reporting Issuer**

**Item 2.                    Date of Material Change**

A material change took place effective January 28, 2020.

**Item 3.                    Press Release**

On January 28, 2020, a news release in respect of the material change was disseminated by the Company.

**Item 4.                    Summary of Material Change**

The Company announced that it has closed a non-brokered private placement financing, pursuant to which it raised gross proceeds of \$589,999.98.

Pursuant to the financing, Mr. Jakson Inwentash subscribed for an aggregate of 5,566,666 units of the Company (“Units”) at a price of \$0.03 per Unit. Mr. Inwentash is an insider of the Company. As of January 28, 2020, immediately prior to the closing of the financing, Mr. Inwentash directly and indirectly held 5,450,000 common shares of the Company and convertible securities entitling Mr. Inwentash to acquire an additional 8,233,333 common shares of the Company, representing approximately 5.9% of the issued and outstanding shares of the Company (and approximately 13.5% on a partially diluted basis, assuming exercise of the convertible securities only). Following the closing of the financing, Mr. Inwentash directly and indirectly holds 11,016,666 common shares of the Company and convertible securities entitling Mr. Inwentash to acquire an additional 13,799,999 common shares of the Company, representing approximately 9.8% of the issued and outstanding shares of the Company post-closing (and approximately 19.7% on a partially diluted basis, assuming exercise of the convertible securities only).

The financing was approved by the board of directors pursuant to directors’ resolutions dated January 28, 2020. The transaction is exempt from the formal valuation and minority shareholder approval requirements of applicable securities laws as at the time the financing was agreed to, neither the fair market value of the subject matter of, or the fair market value of the consideration for, the financing insofar as it involves interested parties, exceeded 25% of the Company’s market capitalization.

The financing was completed to raise proceeds for the acquisition of investments and for general working capital purposes. A material change report is being filed in connection with the insider participation in the financing less than 21 days in

advance of closing of the financing, as the Company did not have prior confirmation of such participation.

Toronto – January 28, 2020 – ThreeD Capital Inc. (the “Company”) (CSE:IDK), a Canadian-based venture capital firm focused on investments in promising, early stage companies and ICOs with disruptive capabilities, is pleased to announce that it has completed a non-brokered private placement (the “Offering”), pursuant to which it has issued 19,666,666 units (“Units”) at a price of \$0.03 per Unit, to raise aggregate gross proceeds of \$590,000. Each Unit consists of one common share of the Company and one common share purchase warrant (a “Warrant”). Each Warrant entitles the holder thereof to acquire one additional common share of the Company at an exercise price of \$0.05 until January 28, 2023.

All securities issued and issuable in connection with the Offering are subject to a statutory hold period expiring on May 29, 2020.

Insiders of the Company subscribed for an aggregate of 5,566,666 Units pursuant to the Offering. Proceeds of the Offering will be used for investment purposes and general working capital.
