The requirement to file this report was triggered by the closing of the Private Placement on December 12, 2022, in which Crescat, an investment manager with discretionary authority operating in the United States, acquired 1,750,000 units of the Issuer (the "Units") at a price of \$0.40 per Unit. Each Unit was comprised of one common share of the Issuer (each, a "Common Share") and one-half of one common share purchase warrant of the Issuer (each whole common share purchase warrant, a "Warrant"). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.70 per Common Share for a term of 30 months. As a result of the Private Placement, the partially diluted holdings in the Issuer of Crescat have risen above 10%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the "**Joint Actors**") may be considered joint actors.
