On May 22, 2020 the Acquiror acquired indirect ownership of common shares and share purchase warrants of the Issuer in a private transaction.

Sutton Ventures Ltd., is a private holding corporation owned and controlled by Brayden Sutton together with his spouse, incorporated pursuant to the laws of British Columbia, and has acquired direct ownership of the securities that are the subject of this report.

The 320,000 common shares and 160,000 share purchase warrants, which are the subject of this report represents 2.5% of the Issuer's current issued and outstanding Common Shares

Prior to the transaction that is the subject of this report, the Acquiror held 1,013,147 common shares in the capital of the Issuer representing 12.98% of the then issued and outstanding common shares of the Issuer and well as 333,333 share purchase warrants.

The Acquiror now exercises control or direction over an aggregate of 1,328,147 common shares of the Issuer, representing 10.37% of the issued and outstanding common shares of the Issuer, and warrants to acquire 493,333 common shares of the Issuer, representing approximately 14.9% of the issued and outstanding shares of the Issuer, on a partially diluted basis assuming the exercise of the convertible securities held by Mr. Sutton only.

The Acquiror acquired indirect ownership and control over 320,000 common shares and 160,000 share purchase warrants that triggered the requirement to file this report through Sutton Ventures Ltd..
