The transaction giving rise to this report was the completion of a share exchange transaction in accordance with the terms of a share exchange agreement dated March 15, 2021 between the Issuer, The BC Bud Holdings Corp. (the "Target") and the shareholders of the Target (the "Share Exchange Agreement"), which resulted in a reverse takeover of the Issuer by the shareholders of the Target on September 29, 2021 (the "Transaction").

On September 29, 2021, the Acquiror acquired, through L5 Capital Inc., a

company controlled by the Acquiror, indirect ownership of common shares of the Issuer pursuant to the Transaction.

L5 Capital Inc. (the "Joint Actor"), is a private holding corporation controlled by the Acquiror, incorporated pursuant to the laws of British Columbia, and has acquired direct ownership of the securities that are the subject of this report.

The 5,250,000 common shares, which are the subject of this report represent 11.71% of the Issuer's current issued and outstanding Common Shares

Prior to the Transaction, the Acquiror held directly and indirectly through the Joint Actor, an aggregate of 950,000 common shares in the capital of the Issuer representing 5.11% of the then issued and outstanding common shares of the Issuer and well as 200,000 share purchase warrants held indirectly through the Joint Actor.

The Acquiror, together with the Joint Actor, now exercises ownership and control over an aggregate of 6,200,000 common shares of the Issuer, representing 13.83% of the issued and outstanding common shares of the Issuer, and warrants to acquire 120,000 common shares of the Issuer, representing approximately 14.21% of the issued and outstanding shares of the Issuer, on a partially diluted basis.

The common shares were issued at a deemed value of \$0.25 each for total consideration of \$1,312,500 in exchange for 2,500,000 common shares of the Target then held by the Joint Actor.
