Common shares (“**Common Shares**”) and common share purchase warrants (“**Warrants**”) of Empatho Holdings Inc. (formerly, Shane Resources Ltd.) (the “**Company**”) with its head office located at 804-750 West Pender Street Vancouver, BC V6C 2T7. Each Warrant entitles the holder thereof to acquire one Common Share.

The Common Shares are expected to trade on the facilities of the Canadian Securities Exchange (the “**CSE**”). The transaction giving rise to this report was the completion of a business combination (the “**Business Combination**”) that resulted in a reverse takeover of the Company by the securityholders of Empatho Corp. (“**Empatho**”) on December 13, 2021.

The closing of the Business Combination resulted in, among other things, the issuance by the Company of an aggregate of 51,800,000 Common Shares to the former securityholders of Empatho. As a result, the Reporter’s deemed beneficial ownership of Common Shares decreased to below 10% on an undiluted and partially-diluted basis.

Prior to the Business Combination, the Reporter held 1,585,156 Common Shares collectively (39.63% of the issued and outstanding Common Shares) and 18,290 Warrants (40.09% of the issue and outstanding Common Shares, calculated on a partially diluted basis that assumes only the exercise of such Warrants). Immediately following the Business Combination, the Reporter held the same number of Common Shares and Warrants; however, such securities represent 2.19% and 2.22% of the issued and outstanding Common Shares on, respectively, an undiluted and partially diluted basis.

Immediately following the Business Combination, the Reporter had ownership or control over 1,585,156 Common Shares, which represents approximately 2.19% of the issued and outstanding Common Shares on an undiluted basis, and 18,290 Warrants, which together with the Common Shares and assuming full exercise of the Warrants, represent approximately 2.22% of the issued and outstanding Common Shares on a partially diluted basis.
