Micromem: Update on Oil and Gas Client Product Developments

Toronto, New York, July 13, 2016: Micromem Technologies Inc. ("Micromem") ("the Company") (CSE: MRM, OTCQX: MMTIF) through its wholly owned subsidiary Micromem Applied Sensor Technologies Inc.
