Toronto, New York, June 29, 2017: Micromem Technologies Inc. ("Micromem") ("the Company") (CSE: MRM, OTCQB: MMTIF) announces it has filed its interim financial statements for the period ended April 30, 2017 together with the Management's Discussion & Analysis on SEDAR and EDGAR. The shares issued are subject to resale restrictions under applicable securities laws.
