Subsequent to the Transaction, the Acquiror owned and controlled 5,591,999 Common Shares of the Issuer representing 22.28% of the then issued and outstanding Common Shares of the Issuer and 2,100,000 warrants of the Issuer based on a total of 25,092,334 Common Shares outstanding or 7,691,999 Common Shares of the Issuer representing 28.28% of the outstanding shares assuming exercise of the 2,100,000 of the Issuer held by the Acquiror.
