The purpose of these funds is for current expenses involving the administration and accounting for the Company. These advances are non interest bearing, unsecured, with no fixed repayment terms. Mr. Robert Salna has advanced Cdn \$135,879 to July 16, 2018. It is anticipated that Mr. Salna will continue to advance funds until management completes a business acquisition. The Board of Directors considers these amounts and the fact that the loans are unsecured to be immaterial to the control of the Corporation.
