The Acquiror acquired 3,200,000 common shares pursuant to the transaction. Previous holdings

were 682,215 common shares post consolidation of October 19, 2018. Together, the total shares held directly and indirectly are now 3,882,215. Currently, the shares issued and outstanding are 10,029,209. The acquiror's percent ownership is now 38.7%.

The Acquiror acquired ownership of 3,200,000 common shares.
