On February 7, 2022, the Acquiror, directly and through Matri Capital Corp. (“**MCC**”), acquired an aggregate of 5,052,385 units (the “**Units**”) of the Issuer by way of private placement at a price of \$0.11 per Unit. Each Unit comprised of one share and one warrant (the “**Warrants**”), with each warrant entitling the holder to acquire a further share of the Issuer at a price of \$0.115 for a period of five year.

4,840,249 Units were acquired by the Acquiror directly and 212,136 Units through MCC on February 7, 2022. Upon completion of the Private Placement Transaction, the

Acquiror's securityholding percentage in the Shares was changed from 0% to approximately 24.63%.

The Acquiror acquired ownership of 5,052,385 Units.

The Acquiror did not hold any securities of the Issuer prior to the Private Placement Transaction.

Following the Private Placement Transaction, the Acquiror beneficially owns and exercises control or direction over 5,052,385 Shares (24.63% of the Issuer's issued and outstanding Shares on an undiluted basis). Assuming full exercise of the Warrants held by the Acquiror, the Acquiror would beneficially own or otherwise exercise control or direction over 10,104,770 Shares (39.53% of the Issuer's issued and outstanding Shares).
