On March 31, 2022, the Acquiror, through Skanderbeg Capital Advisors Inc., acquired 590,831 units (the “**Units**”) of the Issuer by way of private placement at a price of \$0.11 per Unit. Each Unit comprised of one share and one warrant, with each warrant entitling the holder to acquire a further share of the Issuer at a price of \$0.115 for a period of five year.

590,831 Units were acquired by the Acquiror, through Skanderbeg Capital Advisors Inc., on March 31, 2022. Upon completion of the Private Placement Transaction, the Acquiror’s securityholding percentage in the Shares was approximately 25.87%.

The Acquiror acquired ownership of 590,831 Units.

The Acquiror held 5,052,385 Shares and 5,052,385 Warrants prior to the Private Placement Transaction (39.53% of the outstanding shares of the Issuer, on a diluted basis).

Following the Private Placement Transaction, the Acquiror beneficially owns and exercises control or direction over 5,643,216 Shares (25.87% of the Issuer's issued and outstanding Shares on an undiluted basis). Assuming full exercise of the Warrants, the Acquiror would beneficially own or otherwise exercise control or direction over 11,286,431 Shares (41.11% of the Issuer's issued and outstanding Shares).
