On November 26, 2021, the Acquiror acquired ownership and control of 17,000,700 Common Shares (representing 27.07% of the issued and outstanding Common Shares). On November 26, 2021, the Issuer, Legible Media Inc. ("**Legible Media**") and 1284380 B.C. Ltd. ("**Subco**"), a wholly owned subsidiary of the Issuer, completed the previously announced transaction (the "**Transaction**"), pursuant to which Subco amalgamated with Legible Media, and Legible Media become a wholly-owned subsidiary of the Issuer. Pursuant to the Transaction, each of the former holders of Legible Media common shares received common shares of Legible Parent on the basis of one Legible Parent common share for every one Legible Media common share held prior to the closing of the Transaction

Increase or decrease in ownership of securities of the Issuer will depend on numerous conditions, including the price of the Common Shares and general market conditions.
