MANAGEMENT'S DISCUSSION AND ANALYSIS

For the quarter ended March 31, 2016

This Management's Discussion and Analysis ("MD&A") supplements, but does not form part of, the condensed interim unaudited financial statements of Urbana Corporation ("Urbana" or the "Corporation") and notes thereto for the first quarter of 2016 (the "Q1 Financial Statements") and the audited financial statements of Urbana and notes thereto for the year ended December 31, 2015 (the "Annual Audited Financial Statements"). Consequently, the following discussion and analysis of the financial condition and results of operations should be read in conjunction with the Q1 Financial Statements and the Annual Audited Financial Statements, which have been prepared in accordance with International Financial Reporting Standards ("IFRS"). All amounts shown in this MD&A, unless otherwise specified, are presented in Canadian dollars. This MD&A is current as of May 3, 2016. The Corporation's Audit Committee reviewed this document, and prior to its release the Corporation's Board of Directors approved it, on the Audit Committee's recommendation.

CHANGE OF REPORTING REGIME

In 2005, the Corporation became an investment fund for the purposes of applicable securities laws.

On July 13, 2015, shareholders voted to authorize the Corporation, at the sole discretion of its board of directors, from time to time, to seek to exercise control over issuers in which it invests, such that the Corporation would no longer be an investment fund for securities law purposes (the "Reclassification"). As a result of the Reclassification, Urbana is now subject to National Instrument 51-102 ("NI 51-102") *Continuous Disclosure Obligations*, instead of National Instrument 81-106 ("NI 81-106") *Investment Fund Continuous Disclosure* to which it was subject prior to the Reclassification. Under NI 51-102, Urbana is required to file annual and interim Management's Discussion and Analysis. For accounting purposes, Urbana will continue to be treated as an investment entity under IFRS.

Comparative figures for the 1st quarter of the previous year are not available because the Corporation did not start preparing quarterly financial statements until the third quarter of 2015.

BUSINESS STRATEGY AND RISK FACTORS

The long-term strategy of Urbana is to seek and acquire investments for income and capital appreciation through a combination of public and private investments. Urbana has the scope to invest in any sector in any region. There were no material changes to Urbana's investment style

over the first financial quarter of 2016 (“Q1”) that affected the overall level of risk associated with investment in the Corporation. A description of some of the risk factors associated with investing in Urbana are described in Urbana’s annual information form dated March 29, 2016.

OVERALL PERFORMANCE AND DISCUSSION OF OPERATIONS

During Q1 of 2016, publicly traded securities markets experienced a dramatic decline in share prices followed by a steep recovery. From January 1 to February 11, 2016, share prices declined dramatically. The Toronto Stock Exchange Composite Index declined by 7.09% during that timeframe. The most affected sectors were banks, energy and resources.

The turnaround in the fortunes of these groups on February 11 was abrupt, with indexes for the calendar quarter generally ending up approximately even with 2015 year-end numbers. During the quarter, Urbana capitalized on some of the swings in our portfolio investments through both the pre-February 11 decline and the subsequent market up-turn.

Increasingly, market prices of publicly traded securities are now reflecting cautious optimism on energy, China and the overall economy. Urbana remains positive on public equity markets for the near-term. Urbana believes banks on both sides of the border will continue to do well along with the overall resource sector.

While Urbana’s net asset value per share experienced a 3.98% decline in Q1, as of April 1, 2016, as a result of a financing closing, the value of Urbana’s Real Matters Inc. holdings increased its asset value by \$7.9 million.

Urbana continued to reduce some of its U.S. holdings and to purchase shares of major Canadian issuers, which we sometimes refer to as “Canada Inc.”.

One successful trade, resulting from an idea recommended by Caldwell Securities Ltd., was that of Teck Corporation, where we realized \$690,000 in profits in the quarter and have approximately \$2,000,000 in unrealized gains in that holding.

Overall, Urbana realized \$5,872,000 in public share profits in Q1.

Urbana also continued its buy-back of its non-voting Class A shares (“Class A shares”) with the purchase and cancellation of 181,000 shares in Q1 of 2016 at an average price of \$1.87 per Class A share. Urbana has traditionally bought back the maximum number of shares allowable each year under normal course issuer rules. Looking beyond Q1, it appears that the amount of Class A shares offered for sale has thinned out. This may result in reduced purchases, despite our best efforts. If and when larger blocks of Class A shares become available, it is our intention, under the normal course purchase rules, to acquire them.

Our private investments are proving successful, with Real Matters being a standout. On April 4, 2016, we announced that we increased our investment in Real Matters by \$2.479 million, which represented Urbana’s fourth share purchase in Real Matters since December 2013. As of April 4,

2016, Urbana’s Real Matters investment was valued at \$23.6 million and the cost of Urbana’s stake in Real Matters was \$10.55 million.

Radar Capital Inc. is continuing to show growth, and the Bombay Stock Exchange (“BSE”), a position we have held for some time, appears to be making some progress toward an initial public offering of BSE shares (an “IPO”). On March 12, 2016, the Securities & Exchange Board of India (the Indian securities market regulator) gave “approval in principle” for the BSE to become a publicly traded company, that is, to do an IPO. This will provide Urbana with market liquidity one year after the IPO. We are encouraged, but years of delay cause us to have some caution as to timing.

Looking forward in 2016 beyond Q1, we expect some improvement in the oil and metal sectors, continuing low interest rates and slow to moderate economic growth world-wide. These expectations are manifested in the “Canada Inc.” component of our investments.

Our experience in Q1 and in 2015 reinforces our conviction that, in volatile markets, active management can provide better returns than indexed based management styles. Urbana’s management team combines private equity investment with an actively managed portfolio of publicly traded securities. Urbana’s investment performance over the years validates this thesis and operating style.

In Q1, Urbana’s net assets per share decreased by 3.98% from \$3.48 to \$3.29 per share, after payment of a five cents (\$0.05) per share dividend paid to shareholders in February 2016.¹

Dividend income and interest income in Q1 were \$517,415 and \$17,671 respectively. During Q1, Urbana realized a net gain of \$5,739,608 from the sales and dispositions of investments.

In Q1, Urbana recorded a loss before income taxes of \$9,685,096 which is principally attributable to an unrealized loss which reflected the impact of adverse movements in foreign exchange rates in the quarter.

In Q1, investment management fees were \$768,089, foreign withholding tax was \$35,278, and transaction costs were \$247,493.

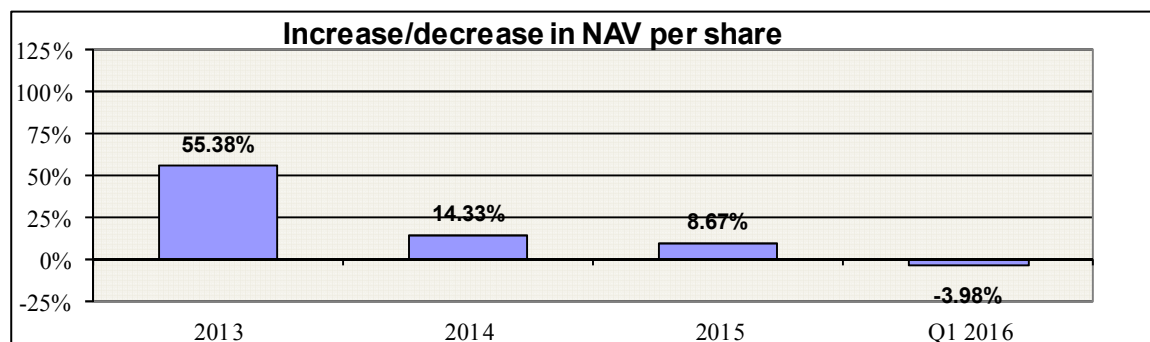
Past Performance

Year-by-Year Performance

The following bar chart shows the net asset value performance of Urbana's common shares for the financial periods indicated. The bar chart shows, in percentage terms, how much an investment made on the first day of each financial period would have grown or decreased by the last day of each financial period based on the net asset value (NAV) per share of Urbana.

Urbana's Class A shares were first issued on January 11, 2007. The Class A shares, which have the same rights as the common shares upon liquidation, are treated as if they are common shares for the purposes of the NAV calculation.

(i) Urbana owns 58.54% of the outstanding shares of Caldwell India Holdings Inc., which holds 4,015,544 equity shares of the Bombay Stock Exchange. Urbana also owns 100 voting ordinary shares of CIHI representing 100% of the ordinary shares. The fair value of these ordinary shares is nominal.

(ii) Urbana Mauritius Inc., which is a wholly-owned subsidiary of Urbana, holds 791,000 equity shares of the Bombay Stock Exchange.

(iii) Urbana Special Investment Holdings Ltd. which is a wholly-owned subsidiary of Urbana, holds 51 shares of OneChicago, LLC.

(iv) Urbana holds an unsecured promissory note repayable on October 22, 2016 with a semi-annual interest payment of 55,902 Class D common shares.

(v) Urbana holds an unsecured promissory note which is non-interest bearing and due on demand.

In addition to the investments listed above, Urbana holds 24,683 common shares of Bermuda Stock Exchange which have been written off and 44 mining claims in Urbana township, Quebec. Mining expenditures of \$81,049 have been recorded as a loss in realized gain on sale and disposal of investments.

Demand Loan Facility

On February 19, 2008, Urbana entered into a demand loan facility with a major Canadian chartered bank (the "Bank"). On March 2, 2015 the loan facility agreement was amended to allow Urbana to borrow up to \$25,000,000. Interest is charged on the outstanding balance of the loan facility at the Bank's prime rate plus 1.25% (prior to March 2, 2015, the Bank's prime rate plus 1.75%), calculated on a daily basis and paid monthly. The loan facility is secured by a general charge on Urbana's assets. Proceeds from the loan may be used for purchasing additional investments and/or for general corporate purposes. As at March 31, 2016, the outstanding balance of the loan was \$10,600,000, representing 6.06% of the net assets of Urbana. The minimum and maximum amount borrowed during Q1 was \$Nil and \$10,600,000 respectively. As at the date of this MD&A, the Corporation has complied with all covenants, conditions or other requirements of the outstanding debt.

Normal Course Issuer Bid

On August 27, 2015, the Toronto Stock Exchange (the "TSX") accepted Urbana's notice of intention to conduct a normal course issuer bid to purchase up to 4,411,688 of its own Class A shares (the "NCIB"), representing 10% of the public float, pursuant to TSX rules. Purchases under the NCIB were permitted starting on August 31, 2015, and will terminate on the earlier of August 30, 2016, the date Urbana completes its purchases pursuant to the notice of intention to make a normal course issuer bid filed with the TSX or the date of notice by Urbana of termination of the bid. The shares purchased under the NCIB must be cancelled. As at March 31, 2016, Urbana has purchased 1,092,600 Class A shares pursuant to the NCIB. These shares were purchased on the open market at an average purchase price of \$1.97 per share.

Mining Claims

Urbana has owned resource properties in Urban Township, Quebec for a number of years. Management monitors the exploration activity in the area on an ongoing basis and may carry out exploration work on its resource properties if and when it is deemed suitable. In November 2014, Urbana entered into a joint exploration agreement with Beaufield Resources Inc. (“Beaufield”), a company that owns neighbouring properties, to explore the Urbana Township region. This exploration program, led by Beaufield, is currently underway. Announcements in 2015 by Beaufield and Oban Mining Corporation have prompted management to expand its exploration program for the property, portions of which have never been drilled.

In Q1, Urbana started the winter work program on the Urban property which consists of additional line-cutting and ground geophysics. On March 4, 2016 Urbana announced that a drill contract has been awarded to Forage Orbit Garant Inc. of Val d'Or and permits have been received for Urbana's 2016 drilling program on the Urban property. On March 7, 2016, Urbana announced the completion of approximately 40 kilometres of line-cutting and the start of a deep-penetrating induced polarization and magnetometer survey on the Urban property. Results of Urbana's winter drilling program on the Urban property are currently being evaluated. Details will be released when available.

Dividend Policy and Dividend Declared

Currently the Corporation has a dividend policy that it intends to pay a cash dividend of five cents (\$0.05) per share to the Shareholders as soon as practical after the end of each year. The amount of dividend to be paid is determined each year by the Board, taking into consideration all

factors that the Board deems relevant, including the performance of the Corporation's investments, the economic and market conditions, and financial situation of the Corporation.

On January 18, 2016, Urbana's board of directors declared a cash dividend of five cents (\$0.05) per share on the issued and outstanding common and Class A shares of Urbana, payable on February 12, 2016, to the Shareholders of record at the close of business on January 28, 2016. Pursuant to subsection 89(14) of the Income Tax Act of Canada (ITA) each dividend paid by Urbana qualifies as and is designated an eligible dividend for Canadian income tax purposes, as defined in subsection 89(1) of the ITA.

Outstanding Share Data

As at May 2, 2016, the Corporation has 10,000,000 common shares and 43,099,100 Class A shares outstanding.

RELATED PARTY TRANSACTIONS

Caldwell Financial Ltd., a company under common management with Urbana, is the parent company of Caldwell Investment Management Ltd. ("CIM"), the investment manager of Urbana. Urbana pays CIM investment management fees for investment management services that CIM provides to Urbana – refer to "Management Fees" below.

Urbana has a 50% ownership interest in Radar Capital Inc. ("RCI"), a private capital company. As at March 31, 2016, Urbana owned 406,066 units of Caldwell Growth Opportunities Trust, which is a private equity pool managed by CIM. Refer to "Summary of Portfolio Investments" above.

Caldwell Securities Ltd., a sister company of CIM and a registered broker and investment dealer, handles Urbana's portfolio transactions. The total amount of commission fees paid to Caldwell Securities Ltd. by Urbana in Q1 of 2016 and during the years ended December 31, 2015, December 31, 2014, December 31, 2013 and December 31, 2012 were \$262,280, \$522,140, \$142,570, \$674,282 and \$279,879 respectively.

In Q1, Urbana paid Caldwell Securities Ltd. \$30,000 per month (plus applicable sales taxes) for investor relations services, office and conference room access for Urbana directors and officers, and accounting services including the services of an individual to perform the function of Urbana's Chief Financial Officer.

As at March 31, 2016, there were no fees payable to related parties, other than a management fee payable of \$768,089 to CIM.

MANAGEMENT FEES

Investment management fees are charged for portfolio management services in accordance with a fund management and portfolio management agreement effective as of August 1, 2011 between Urbana and CIM. Pursuant to such agreement, CIM is entitled to an investment management fee equal to 1.5% per annum of the market value of Urbana's investment portfolio. In Q1, CIM earned \$768,089 of investment management fees from Urbana. The investment management fees

are accrued and paid quarterly in arrears. As at March 31, 2016 there was an investment management fee payable of \$768,089 to CIM.

LIQUIDITY AND CAPITAL RESOURCES

The Corporation currently holds more than 55% of its assets in marketable securities. It does not anticipate any issues with liquidity.

The Corporation has had a demand loan facility with a major Canadian bank since 2008 (see under the heading of "Demand Loan Facility" above). In Q1, the Corporation did not conduct any additional financing activities. As at the date of this MD&A, the Corporation does not have any capital expenditure commitment which the Corporation plans on funding by way of financing arrangements in addition to the existing loan facility.

OFF-BALANCE SHEET ARRANGEMENTS

There are no off-balance sheet arrangements.

CHANGES IN ACCOUNTING POLICIES

In July 2014, the final version of IFRS 9 Financial Instruments ("IFRS 9") was issued, which replaces IAS 39. In July 2014, the final version of the International Financial Reporting Standard 9 Financial Instruments ("IFRS 9") was issued, which replaces International Accounting Standard 39 – Financial Instrument: Recognition and Measurement. IFRS 9 includes guidance on the classification and measurement of financial instruments, impairment of financial assets, and hedge accounting. Financial asset classification is based on the cash flow characteristics and the business model in which an asset is held. The classification determines how a financial instrument is accounted for and measured. IFRS 9 also introduces an impairment model for financial instruments not measured at fair value through profit or loss that requires recognition of expected losses at initial recognition of a financial instrument and the recognition of full lifetime expected losses if certain criteria are met. A new model for hedge accounting aligns hedge accounting with risk management activities. IFRS 9 is effective for annual periods beginning on or after January 1, 2018. The Corporation is currently assessing the impact the adoption of this standard will have on the financial statements.

In December 2014, a disclosure initiative was issued, which amends IAS 1 Presentation of Financial Statements. The amendments are designed to encourage entities to use professional judgment to determine what information to disclose in the financial statements and accompanying notes by clarifying the guidance on materiality, presentation, and note structure. These amendments are effective for annual periods beginning on or after January 1, 2016.

DISCLOSURE CONTROLS AND PROCEDURES (“DC&P”) AND INTERNAL CONTROL OVER FINANCIAL REPORTING (“ICFR”)

Urbana’s management (“Management”), under the supervision of its CEO and CFO, is responsible for establishing and maintaining the Corporation’s DC&P and ICFR (as defined in National Instrument 52-109 – *Certification of Disclosure in Issuers’ Annual and Interim Filings*).

Consistent with NI 52-109, the Corporation's CEO and CFO have reviewed the design of the Corporation’s DC&P and ICFR and have concluded that as at March 31, 2016 (A) the Corporation’s DC&P provides reasonable assurance that (i) material information relating to the Corporation has been made known to them, particularly during the financial quarter ended March 31, 2016 and (ii) information required to be disclosed by the Corporation in its annual filings, interim filings or other reports filed or submitted by it under securities legislation has been recorded, processed, summarized and reported within the time periods specified in securities legislation; and (B) the Corporation’s ICFR provides reasonable assurance regarding the reliability of financial reporting and the preparation of financial statements for external purposes in accordance with International Financial Reporting Standards.

There have been no changes in the Corporation’s ICFR that occurred during the period beginning January 1, 2016 and ending on March 31, 2016 that has materially affected, or is reasonably likely to materially affect, the Corporation’s ICFR.
