On September 4, 2020, GCC disposed of 22,000,000 Common Shares of the Issuer (the “**Disposition**”). The Disposition was carried out pursuant to various private share purchase transactions.

Prior to the Disposition, GCC held 26,639,533 Common Shares and 1,162,533 Common Share purchase warrants (“**Warrants**”) of the Issuer, representing approximately 44.64% of the Issuer’s issued and outstanding Common Shares on an undiluted basis and approximately 45.7% of the Issuer’s issued and outstanding Common Shares on a partially diluted basis (assuming exercise of all Warrants). Upon completion of the Disposition, GCC now holds 4,639,533 Common Shares

and 1,162,533 Warrants, representing approximately 7.77% of the Issuer's issued and outstanding Common Shares on an undiluted basis and approximately 9.53% of the Issuer's issued and outstanding Common Shares on a partially diluted basis (assuming the exercise of all Warrants).

After giving effect to the Disposition, GCC beneficially owns and controls 4,639,533 Common Shares and 1,162,533 Warrants, representing approximately 7.77% on an undiluted basis and approximately 9.53% on a partially diluted basis assuming exercise of all Warrants.

The share purchase agreements entered into between GCC and the various purchasers provide for nominal consideration, however, the Disposition was carried out for the purpose of acknowledging the efforts of businesses and other affiliates made directly and indirectly in the development of the Issuer. As a result, the nominal consideration provided for in the share purchase agreements may not reflect the actual value of the transaction, resulting in the Disposition being made for an indeterminate value.

The Disposition was carried out for the purpose of acknowledging the efforts of businesses and other affiliates made directly and indirectly in the development of the Issuer. GCC has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. GCC currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Issuer's business and financial condition and/or other relevant factors, GCC may develop such plans or intentions in the future.
