On June 25, 2018, the Company issued 820,826 Common Shares to the Acquiror pursuant to the completion of the Debt Settlement.

Mr. Lustig now owns an aggregate of 1,320,826 Common Shares in the capital of the Company and common share purchase warrants (“**Warrants**”) exercisable for the purchase of 500,000 Common Shares, representing 13.51% of the issued and outstanding Common Shares on a non-diluted basis, and 17.71% on a partially-diluted basis (assuming exercise of Mr. Lustig’s convertible securities).

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.

The Acquiror acquired ownership of or control over 820,826 Common Shares.

Following the Debt Settlement, Mr. Lustig now owns an aggregate of 1,320,826 Common Shares and Warrants exercisable for the purchase of 500,000 Common Shares, representing 13.51% of the issued and outstanding Common Shares on a non-diluted basis, and 17.71% on a partially-diluted basis (assuming exercise of Mr. Lustig’s convertible securities).
