

Molecule Holdings Provides Update on Sales Amendment Submission with Health Canada

Ottawa, ON November 10, 2021 – Molecule Holdings Inc. (CSE: MLCL) ("Molecule" or the "Company"), a Canadian craft-focused cannabis beverage production company, is pleased to announce that it is entering the final stages of Health Canada's review regarding "adding the activity of sale" to its processing licence. Commonly referred to as "a sales amendment", this application was submitted on August 29, 2021. After much review with Health Canada, we understand the process is now nearing completion.

The addition of the sales amendment will allow for direct sale to the provinces, thereby opening the door to a number of potential significant advantages and opportunities for the business including: direct savings on commissions paid through the Company's current sales amendment partnership; direct provincial communication; and a potential new and significant revenue stream if we choose to act as a sales amendment broker for other companies looking to enter into the cannabis market.

David Reingold, Molecule CEO stated that, "Receiving final approval of the sales amendment is critical to the business. We are quite excited to be almost through this process. National expansion and direct in store placement will now be the absolute focus of our business. We are very confident in our ability to compete at every level in the beverage category including price, innovation and branding."
