

Molecule Holdings Inc.'s Phresh Strawberry Kiwi Receives High Ranking on Ontario Cannabis Stores

Ottawa, ON December 1, 2021 – Molecule Holdings Inc. (CSE: MLCL) (OTC: EVRRF) ("Molecule" or the "Company"), a Canadian craft-focused cannabis beverage production company, is pleased to update investors on the company's sales rankings on its Phresh branded products which are currently available in the Ontario market.

With a launch in July 2021, <u>Phresh's Strawberry Kiwi</u> sugar-free beverage, infused with 10 mg of THC has been climbing the ranks amongst the top sellers in Ontario. In the 3 months ending November 30th, the beverage has experienced a store penetration rate of 36%, achieving a rank of 'Top 4' in the Ontario Cannabis Store ("OCS") to dispensary unit sales. Presh's Strawberry Kiwi has also achieved a 'Top 2' status in 10mg Online Unit Sales through the OCS retail site.

Furthermore, according to Headset.io the company's Phresh Strawberry Kiwi beverage has also been ranked "Top 3" as Ontario's Best Selling Cannabis Beverages across all private retail outlets in the Province of Ontario¹.

CEO David Reingold stated, "We are very proud of the progress Phresh has made against Ontario's fastest selling drinks in such a short period of time. Our store teams are focused on increasing store penetration and continuing driving momentum and performance in the market."

The Phresh brand is the only single-SKU branded product in the top sellers category, whereby the majority of its competitors have had significantly more time in the market. Phresh is driving sales through nostalgic and classic flavour combinations at an affordable price point for both an 'add on' purchase and/or an entry point for people who are curious about the effects of cannabis beverages.

"The innovation we have planned to expand the Phresh footprint with new flavours and profiles is also very extensive, we expect additional Phresh launches into the market in early 2022." David added.
