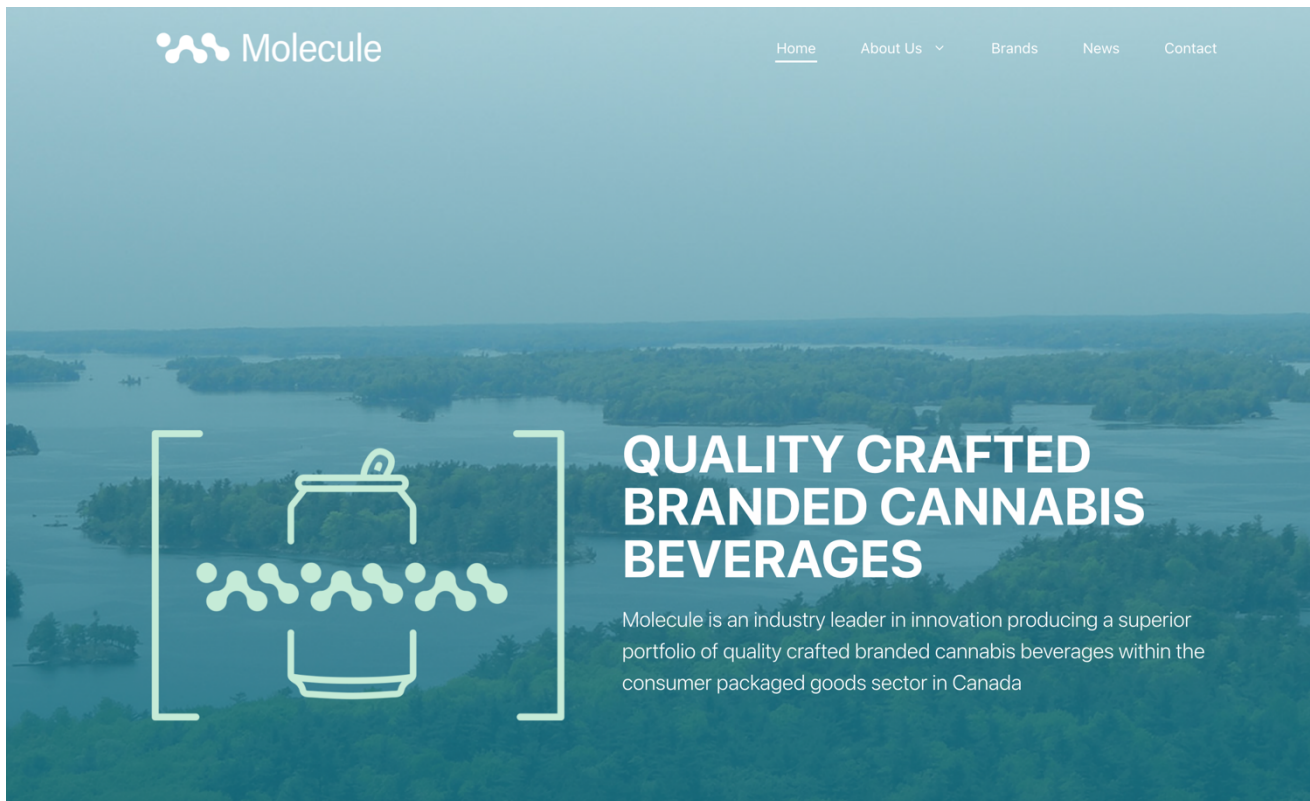




## **Molecule Holdings Inc. Launches Corporate Website**
