#### 3. News Release:

On July 4, 2014, MicroCoal Technologies Inc. (the "Company") issued a news release through the facilities of FSC Filing Services Canada.

# 4. Summary of Material Change:

On July 4, 2014, the Company announced that it closed the fourth tranche of its non-brokered private placement (the "**Private Placement**") in the amount of US\$167,000. Pursuant to the Private Placement, the Company issued 835,000 units (each, a "**Unit**") of the Company at a subscription price of US\$0.20 per Unit.

# 5. Full Description of Material Change:

On July 4, 2014, the Company announced that it closed the fourth tranche of the Private Placement in the amount of US\$167,000. Pursuant to the Private Placement, the Company issued 835,000 Units of the Company at a subscription price of US\$0.20 per Unit.

Each Unit is comprised of one common share of the Company and one common share purchase warrant (the "Warrants"). Each Warrant will entitle the holder thereof to acquire one common share at an exercise price of US\$0.30 for up to 12 months following the date of issuance, subject to the terms thereof. In connection with the first tranche, the Company paid a cash commission equal to 10% of the gross proceeds raised from the sale of the Units to an arm's length party in the aggregate amount of approximately US\$16,700 and granted finder's warrants to purchase Units equal to 10% of the Units placed.

The Company intends to use the net proceeds from the Private Placement to advance construction on the Company's first commercial facility in Indonesia for upgrading low rank coals and for general corporate purposes and working capital. All Units, common shares and Warrants issued under the Private Placement will be subject to a four-month hold period from the closing date, in accordance with the rules and policies of the Canadian Securities Exchange and applicable Canadian securities laws and such other restrictions as may apply under foreign securities laws.
