The Ram West claim group has exploration potential for copper-cobalt-nickel below these claims and is in close proximity to the RAM option claims.

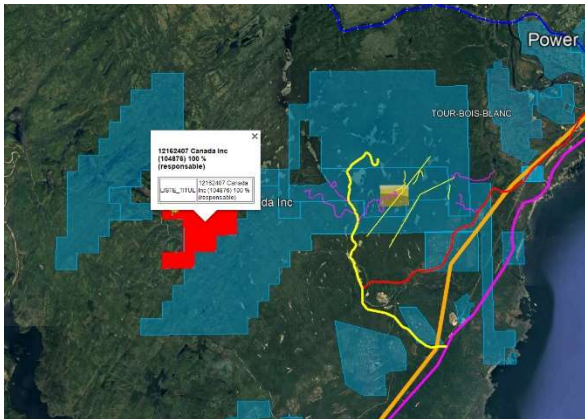
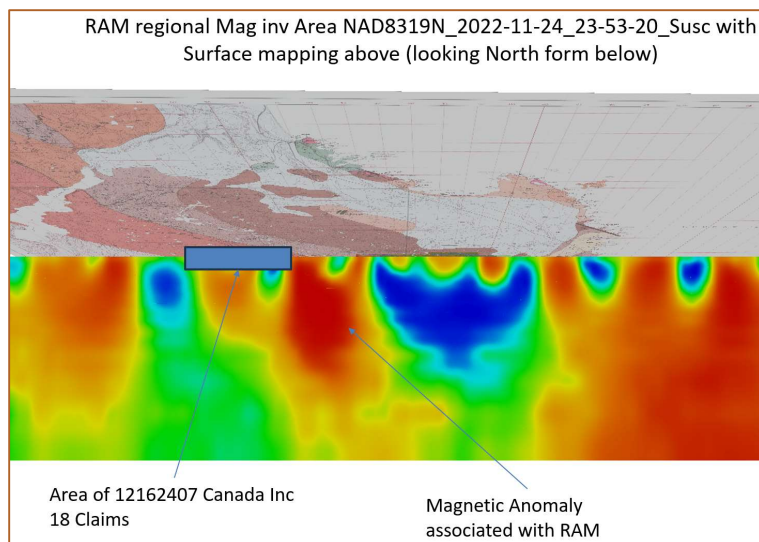


Figure 1. Location of 12162407 Canada Inc Claims (red)
