On December 9, 2011, McLean Budden filed an early warning report which disclosed that on April 14, 2011, McLean Budden acquired a total of 2,888,889 units (the "Units") in the capital of Thelon Capital Ltd. ("Thelon") at a price of \$0.45 per Unit for a total cash subscription price of \$1,300,000. Each Unit consisted of one previously unissued non-flow through common share (the "Common Shares") of Thelon and one common share purchase warrant (the "Warrants"). As a result, McLean Budden became the beneficial owner of 2,888,889 Common Shares and 2,888,889 Warrants.

On August 9, 2012, McLean Budden disposed of a total of 1,999,889 Common Shares and 155,000 Warrants. As a result, McLean Budden had disposed of all of its holdings of Common Shares and became the beneficial owner 2,733,889 Warrants, representing 0% and 6% of the outstanding Common Shares and Warrants, respectively.
