THC2GO Dispensers Submits Application to Manitoba Government For Retail Cannabis Stores.

THC Receives Health Canada Permission To Add 4 Extra Grow Rooms.

THC is also pleased to announce that Health Canada has amended THC's ACMPR license to include 4 additional Grow Rooms. These additional Grow Rooms will allow THC to ramp up production, substantially adding an additional 400kg per annum. THC expects in the next few months to be the first Licensed Producer to offer a consistent supply of 21 different strains. The 4 Grow Rooms went into production on Friday the 15<sup>th</sup> December 2017.

THC further announces that it has entered into negotiations to purchase a greenhouse business in Ontario, Canada's most populated province. The greenhouse business has been operating for more than 20 years and is well suited for growing cannabis. Successful completion of the acquisition would immediately give THC 100,000 square feet grow capacity with both facilities combined and an expansion capability of 300,000 square feet.

THC is further pleased to announce that it has had its facility inspected for Good Production Practices to enable the export of products to the European Union. We expect positive results from the inspection and hope to receive certification soon.
