On February 13, 2019 the acquiror acquired 4,510,204 Shares of the Issuer pursuant to the Earn Out Share provisions of the original share exchange agreement dated October, 2014, as amended on January 14, 2015, (the “**Agreement**”) for the reverse takeover taking the Issuer public in April of 2015.

John Miller may be considered a joint actor of the Acquiror.

4,510,204 common shares were acquired. There is a positive 2% change in the acquiror’s securityholding percentage in the class of securities.

Following the acquiror’s acquisition of Shares on February 13, 2019 the acquiror owns 18,034,572 Shares of the Issuer representing approximately 12.8% of the current issued and outstanding shares.

Together, the acquiror and Hee Jung Chun own an aggregate of 43,352,643 Shares, 2,000,000 Stock Options, and 4,353,737 Warrants, representing approximately 30.7% of the current issued and outstanding Shares on a non-diluted basis and 33.68% on a partially-diluted basis assuming exercise of the Stock Options and Warrants.
