On March 8, 2021, 500,000 of the acquirors Stock Options expired.

On March 8, 2021, 500,000 of the acquirors Stock Options expired. There is a negative 2.6% change in the acquiror's securityholding percentage in the class of securities since the date of the last early warning report.

The acquiror ceased to have control over the Stock Options.

In the last early warning report filed by the acquiror, the acquiror owned 18,034,572 Common Shares and 1,000,000 Stock Options. If the Stock Options are fully exercised, they will represent approximately 12.8% of the then issued and outstanding Common Shares on a partially-diluted basis.

Following the acquiror's expiry of Stock Options on March 8, 2021 the acquiror owns 16,162,072 Common Shares and 550,000 Stock Options. If the Stock Options are fully exercised, they will represent approximately 10.2% of the current issued and outstanding Common Shares on a partially-diluted basis.

Together, the acquiror and John Miller own an aggregate of 47,313,476 Common Shares, 1,100,000 Stock Options and 9,523,342 Warrants. The Common Shares represent approximately 28.9% of the current issued and outstanding Common Shares on a non-diluted basis. The Common Shares, Stock Options and Warrants represent approximately 33.2% on a partially-diluted basis, assuming exercise of the Stock Options and Warrants.
