In the last early warning report filed by the acquiror, the acquiror owned 16,162,072 Common Shares and 550,000 Stock Options. If the Stock Options are fully exercised, they will represent approximately 10.2% of the then issued and outstanding Common Shares on a partially-diluted basis.

Following the acquiror's expiry of Stock Options on February 12, 2023 the acquiror owns 16,212,072 Common Shares, representing approximately 9.9% of the current issued and outstanding Common Shares.

The acquiror and John Miller, through a private company, own two convertible debentures exercisable into Common Shares (the "Convertible Debentures").

The first is a \$500,000 Convertible Debenture, convertible into 5,000,000 Common Shares at \$0.10 of the Issuer. The Convertible Debenture is dated August 10, 2021. The term of the Convertible Debenture is 24 months (2 years) and bears interest at 10% per annum calculated on an annual basis and payable monthly.

The second is a \$250,000 Convertible Debenture, convertible into 3,125,000 Common Shares at \$0.12 of the Issuer. The Convertible Debenture is dated January 7, 2022. The term of the Convertible Debenture is 12 months (1 year) and bears interest at 12% per annum calculated on an annual basis and payable monthly.

In the event that acquiror and Hee Jung Chun convert the debt into Common Shares, the acquiror and Hee Jung Chun would own an aggregate of 55,713,476 Common Shares. The Common Shares would represent approximately 32.4% of the current issued and outstanding Common Shares on a non-diluted basis.
