# MANAGEMENT'S DISCUSSION AND ANALYSIS ("MD&A") For the Period Ended November 30, 2020 and 2019

The following management's discussion and analysis, prepared as of January 19, 2021 should be read together with the unaudited condensed interim financial statements for the period ended November 30, 2020 and related notes attached thereto (the "financial statements"), the audited financial statements for the year ended February 29, 2020 and related notes attached thereto (the "financial statements"), which are prepared in accordance with International Financial Reporting Standards

("IFRS"). All amounts are stated in Canadian dollars unless otherwise indicated. Readers may also want to refer to the February

On June 25, 2020 the Company consolidated its stock on a 10:1 basis. This MD&A reflects that consolidation on a retroactive basis.

### **DESCRIPTION OF THE BUSINESS**

Victory Resources Corporation. (Formerly Victory Empire Inc.), ("Victory" or "The Company") is a publicly traded company. It changed its name on November 6, 2019 to Victory Empire Inc. and on March 19, 2020 to Victory Resources Corporation. The Company has been a junior exploration stage mining corporation with interests in North America. The Company has no plans to divest itself of its existing operations in respect of its assets in South Central British Columbia. The Corporation's current mining asset is a 100% interest in a prospective mineral property in South Central British Columbia known as the "Toni Property", subject to a 2% net smelter return royalty. Victory holds claims known as the AW NORTH, the AW EAST and the MalWen corner, comprising 2,331.05 hectares which presently make up the Toni Property. Due to the high costs of holding a large land package during times of difficulty for junior explorers, the Company has reduced the Toni Property to the essential core claims and has let the balance lapse. To date, the Company has not generated significant revenues from operations. The Company has not yet determined whether the Toni Property contains mineral reserves that are economically recoverable. On September 22, 2020 the Company announced the arms-length acquisition of the Las Simard Property in Quebec. To earn the interest, the Company issued 5,000,000 shares on November 16, 2020 and paid \$25,000. The shares will be subject to a fourmonth hold. The Company announced that it will focus on its mineral exploration project, the Mal-Wen property located near Merritt, BC, with an exploration program consisting of geological mapping and sampling, over burden survey and airborne magnetometer and IP surveys. It is anticipated that this program will cost approximately \$150,000 and be completed in the third quarter of this year. During the period ended November 30, 2020 the Company spent \$26,875 for surveys. The Company entered into an option agreement dated December 1 2020, with Silver Range Resources LTD. to acquire the right to acquire an 80% interest in the Loner Property, located in USA. To acquire the right, the Company is must make cash payments totaling \$400,000. On December 20, 2020, the Company paid \$20,000.

### INVESTMENTS AND DEPOSITS

#### **Deposits**

CIA Cannabis Intelligence Agency Inc. ("CIA")

During the year ended February 29, 2020, the Company entered into an LOI with CIA towards an equity investment. The Company advanced \$80,000 to CIA towards the acquisition by way of a secured loan bearing interest at 8% and repayable in one year. Security on the loan consists of a general security interest against the assets and undertakings of CIA. The Company has recorded this amount as a deposit until such time as the transaction is completed and shares of CIA are received.

### **Long-term investments**

### Glenbriar Technologies Inc. ("Glenbriar")

During the year ended February 29, 2020, the Company sent \$150,000 to Glenbriar for the future issuance of common shares. The Company has recorded this amount as a deposit at February 29, 2020. On March 20, 2020, the Company received 6,000,000 common shares with respect to this deposit. The Company recorded \$90,000 unrealized capital loss on August 31, 2020.

#### World High Life PLC ("World High Life")

On October 22, 2019, the Company purchased 6,666,670 convertible debenture units (the "Debentures") of World High Life for \$1,100,000. World High Life is a UK CBD wellness and medicinal cannabis investment company listed on the London NEX Exchange under the symbol LIFE. The debentures pay interest of 10% annually, and are convertible into ordinary shares of World High Life at a price of £0.10 per share, subject to World High Life's right to force conversion upon 30 days' notice in the event that the Ordinary Shares trade at £0.30 or higher for a 10 day period. The debenture units consisted of a £1.00 principal amount and included 1 warrant to purchase additional ordinary shares at a price £0.15 per share for two years (6,666,670 warrants in total), subject to World High Life's right to accelerate the maturity date upon 30 days' notice in the event that the Ordinary Shares trade at £0.25 or higher for a 10 day period. The debentures mature two years plus one day from closing.

On October 22, 2019, the initial fair value of the convertible debenture was determined to be the initial cost of \$1,100,000, which was split between the principal note and the conversion feature as \$606,498 and \$493,502, respectively. Initially, \$Nil was allocated to the warrants received.

On July 3, 2020 the Company converted all of the debentures and interest into 7,182,138 World High Life shares. The Company recorded a \$337,763 realized loss on the investment. The Company also recorded a \$520,137 unrealized loss for the nine month period ended November 30, 2020.

#### As at November 30, 2020:

- i) the warrants were fair valued at \$236,956 (February 29, 2020 \$321,570) using the Black- Scholes option pricing and discounted cash flow models with following assumptions: estimated share price of £1.075; conversion price of £1.50; risk-free interest rate of 1.84%; dividend yield of 0%; stock price volatility of 100%, an expected life of 1.11 years (February 29, 2020 1.65 years).
- ii) during the period ended November 30, 2020, the Company recorded \$95,572 of interest income.
- During the period ended August 31, 2020, the Company entered into a loan agreement with World High Life whereby the Company loaned World High Life \$300,000 with an annual interest rate of 10% repayable by January 30, 2021. The Company recorded interest income of \$7,840 during the period ended November 30, 2020. The Company entered into a settlement agreement with World High Life on November 10, 2020. 9,196,950 World High Life common shares at GBP 0.02 for total consideration GBP 183,749 including interest GBP 4,696 were issued on November 24, 2020.

Title to exploration and evaluation assets involves certain inherent risks due to the difficulties of determining the validity of certain claims that may be impacted by the conveyancing history characteristic of many mineral properties. The Company has investigated title to all of its mineral properties, and to the best of its knowledge, title to all of its properties is properly registered and in good standing.

# Toni Property, Nicola Division, British Columbia

The Company has a 100% interest in the Toni Property and is not aware of any charges, encumbrances or claims. As consideration the Company paid \$30,000, issued 30,000 common shares and incurred at least \$250,000 in cumulative exploration expenditures during the years ended February 28, 2006 and 2007. The property is subject to a 2% net smelter returns royalty.

During the year ended February 28, 2019, the Company determined the Toni Property to be impaired and wrote down the carrying value to \$10,000 in accordance with level 3 of the fair value hierarchy.

#### Hammond Reef South, Ontario

The Company entered into an agreement dated July 27, 2020, and amended on August 5, 2020 with Abitibi Royalties Inc., to earn a 100% interest in the Hammond Reef South Project, in Northwestern Ontario. To earn the interest, the Company is must make cash payments totaling \$275,000 and issue a total of 2,750,000 common shares to Abitibi Royalties Inc. On August 31, 2020, the Company paid \$50,000 and issued 500,000 shares at a fair value of \$100,000.

#### Rich Lake Lithium Property, Ontario

During the year ended February 29, 2016, the Company acquired claims in the area designated as the Rich Lake Lithium Property.

During the year ended February 28, 2017, the Company entered a joint venture with Urban Mining Ventures Inc. in which Urban Mining Ventures Inc. could earn 25% of the mineral rights on the Rich Lake Lithium Property.

During the year ended February 28, 2017, Urban Mining Ventures Inc. abandoned the joint venture agreement.

During the year ended February 28, 2018, the Company determined the Rich Lake Lithium Property to be impaired and wrote down the carrying value to \$1 in accordance with level 3 of the fair value hierarchy.

#### Las Simard Property, Quebec

On September 22, 2020 the Company announced the arms-length acquisition of the Las Simard Property in Quebec. To earn the interest, the Company subsequently issued 5,000,000 shares and paid \$25,000. The shares will be subject to a four-month hold.

## Wal-Wen Property, British Columbia

The Company announced that it will focus on its mineral exploration project, the Mal-Wen property located near Merritt, BC, with an exploration program consisting of geological mapping and sampling, over burden survey and airborne magnetometer and IP surveys. It is anticipated that this program will cost approximately \$150,000 and be completed in the third quarter of this year. During the period ended November 30, 2020 the Company spent \$26,875 for surveys.

### LIQUIDITY, CAPITAL RESOURCES AND COMMITMENTS

# **Continuance of Operations and Going Concern**

The condensed interim financial statements are prepared on a going concern basis which assumes that the Company will be able to realize its assets and discharge its liabilities in the normal course of business for the foreseeable future. As at November 30, 2020, the Company has a deficit of \$31,614,917 (February 29, 2020 - \$29,412,380). The Company is in the process of exploring and developing its mineral properties and has not yet determined whether those properties contain ore reserves that are economically recoverable. The recoverability of the amounts shown for exploration and evaluation assets is dependent upon the discovery of economically recoverable reserves, the ability of the Company to obtain necessary financing to fund property commitments and to complete the exploration and development of the properties and upon achieving future profitable production or proceeds from the disposition thereof. These uncertainties may cast significant doubt about the Company's ability to continue as a going concern.

The Company has financed its operations primarily through the issuance of common shares, proceeds from loans and advances from related parties. The Company continues to seek capital through various means including the issuance of equity and/or debt. While the Company has been successful in securing financing in the past, there is no assurance that it will be able to do so in the future or on terms that are favorable to the Company. Accordingly these financial statements do not give effect to adjustments, if any, that would be necessary should the Company be unable to continue as a going concern. If the going concern assumption was not used then the adjustments required to report the Company's assets and liabilities on a liquidation basis could be material to these financial statements.

In March 2020, the World Health Organization declared coronavirus COVID-19 a global pandemic. This contagious disease outbreak, which has continued to spread, and any related adverse public health developments, has adversely affected workforces, economies, and financial markets globally, potentially leading to an economic downturn. It is not possible for the Company to predict the duration or magnitude of the adverse results of the outbreak and its effects on the Company's business or ability to raise funds.

#### Liquidity

At November 30, 2020, the Company had working capital of \$415,961 (At February 29, 2020 - \$97,423).

During the period ended November 30, 2020, the Company had the following cash flows:

- 1) cash used in operating activities of \$1,989,031 consisting primarily of general operational costs including consulting fees, management fees and professional fees.
- 2) cash provided by financing activities of \$2,420,309 consisting primarily of proceeds of \$2,301,425 from the issuance of shares and \$150,000 in loans repayable.
- 3) cash used in investing activities of \$74,563 consisting primarily of an exploration option payment of \$50,000.

During the period ended November 30, 2020, the Company continued to seek capital through various means including the issuance of equity and/or debt.

#### **Capital Resources**

As our exploration-stage properties are not revenue generating, the Company's sole source of long-term funding has traditionally been the issuance of common shares for cash, primarily through private placements to sophisticated investors.

The Company has traditionally supplemented equity financing from time to time by obtaining loans from related parties. These are used to provide interim, short-term financing to meet day-to-day cash flow needs, on occasion, and are not intended to be a long-term source of capital.

#### **Off-Balance Sheet Arrangements**

The Company has no off-balance sheet arrangements.

There are no proposed transactions that have not been disclosed herein.

# **Results of Operations**

For the nine months ended November 30, 2020

Below are the significant changes in expenses when comparing the nine months ended November 30, 2020 to the nine months ended November 30, 2019:

- Advertising and promotion fees of \$379,605 (2019 \$475,316) decreased primary as a result of a decrease in prospective business developments initiatives.
- Consulting increased to \$605,259 (2019 \$136,868) as a result of increased activities.
- Travel decreased to \$2,026 (2019 \$89,528) as a result of travel restrictions during COVID-19 pandemic.
- Other variations in expenses in the period presented reflect the variation inherent in normal course operations. We expect other items to remain at relatively constant levels, as these primarily reflect recurring operational expenses that do not vary significantly within a certain range of corporate and exploration activity.

For the three months ended November 30, 2020

Below are the significant changes in expenses when comparing the three months ended November 30, 2020 to the three months ended November 30, 2019:

- Advertising and promotion fees of \$181,132 (2019 \$127,625) increased primary as a result of an increase in prospective business developments initiatives.
- Consulting increased to \$244,979 (2019 \$27,800) as a result of increased activities.
- Professional fees increased to \$39,623 (2019 \$63,541) as a result of legal fees incurred related to increased corporate activities during the previous period.
- Travel decreased to \$2,026 (2019 \$10,452) as a result of travel restrictions during COVID-19 pandemic.
- Other variations in expenses in the period presented reflect the variation inherent in normal course operations. We expect other items to remain at relatively constant levels, as these primarily reflect recurring operational expenses that do not vary significantly within a certain range of corporate and exploration activity.

For the three months ended November 30, 2020, the Company incurred a net loss of \$2,202,538 primarily due to unrealized capital loss as a result to reduced market price of long term investments and advertising and promotion expenses and professional advertising and promotion expenses and professional costs incurred during the current period as a result of prospective business developments initiatives.

For the three months ended August 31, 2020, the Company incurred a net loss of \$1,431,577 primarily due to unrealized capital loss as a result to reduced market price of long term investments and advertising and promotion expenses and professional

advertising and promotion expenses and professional costs incurred during the current period as a result of prospective business developments initiatives.

For the three months ended May 31, 2020, the Company incurred a net loss of \$195,416 primarily due to loss as a result to advertising and promotion expenses and professional costs incurred during the current period as a result of prospective business developments initiatives.

For the three months ended February 29, 2020, the Company incurred a net loss of \$97,928 primarily due to advertising and promotion expenses and professional costs incurred during the current period as a result of prospective business developments initiatives.

For the three months ended November 30, 2019, the Company incurred a net loss of \$97,514 primarily due to an unrealized gain on long-term investments of \$370,769 offset by advertising and promotion expenses and professional costs incurred during the current period as a result of prospective business developments initiatives.

For the three months ended August 31, 2019, the Company incurred a net loss of \$351,540 primarily due to advertising and promotion expenses and professional costs incurred during the current period as a result of prospective business developments initiatives.

For the three months ended May 31, 2019, the Company incurred a net loss of \$320,269 primarily due to professional and consulting costs incurred during the current period.

For the three months ended February 28, 2019, the Company incurred a net loss of \$2,173,061 primarily due to write down of the Toni Property during the current period.

# FINANCIAL AND OTHER INSTRUMENTS

The Company's financial instruments consist of cash, amounts receivable, deposits, reclamation deposits, long-term investments, accounts payable and accrued liabilities and due to related parties. Cash and long-term investments are carried at fair value. The fair values of amounts receivable, deposits, accounts payable and accrued liabilities and due to related parties approximate their carrying amounts due to their current nature.

Financial instruments measured at fair value are classified into one of three levels in the fair value hierarchy based on the degree to which the inputs used to determine the fair value are observable. The three levels of the fair value hierarchy are:

- Level 1 quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2 inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs for the asset or liability that are not based on observable market data (unobservable inputs).

# RISKS AND CAPITAL MANAGEMENT

Credit risk

Credit risk is the risk that one party to a financial instrument will fail to discharge an obligation and cause the other party to incur a financial loss. Credit risks associated with cash are minimal as the Company deposits the majority of its cash with a large Canadian financial institution. The Company's credit risks associated with its amounts receivable are monitored by management. The Company's exposure to potential loss is equal to the carrying value of the amounts receivable.

### Liquidity risk

Liquidity risk is the risk that the Company will encounter difficulty in meeting obligations associated with financial liabilities. The Company manages liquidity risk through the management of its capital structure, as outlined below. As at November 30, 2020, the Company had a cash balance of \$394,335 (February 29, 2020 - \$38,620), GST receivable of \$41,553 (February 29, 2020 - \$12,011) and amounts receivable of \$Nil (February 29, 2020 - \$56,089) to settle current liabilities of \$171,446 (February 29, 2020 - \$276,611). All of the Company's trade accounts payable and amounts due to related parties have contractual maturities of 30 days or are due on demand and accounts payable are subject to normal trade terms. The Company will require financing from lenders, shareholders and other investors, or liquidation of long-term investments to generate sufficient capital to meet its short term business requirements. The Company is planning additional financings in the near term to raise working capital to finance its ongoing operations.

#### Market risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates, foreign exchange rates, and commodity and equity prices.

#### a) Interest rate risk

As of November 30, 2020, the Company did not hold any material investments or liabilities and has no significant interest rate risk.

#### b) Foreign currency risk

Foreign currency risk is the risk that the fair value of future cash flows will fluctuate as a result of changes in foreign exchange rates. At November 30, 2020, the Company's functional currency is the Canadian dollar and major purchases are transacted in Canadian dollars. The Company has foreign currency exposure with respect to the investment in World High Life, which is denominated in British Pounds. A 5% change in the value of the British Pound with respect to the Canadian Dollar would impact profit or loss by approximately \$35,253.

#### c) Price risk

The recoverability of the Company's exploration and evaluation assets is indirectly related to the market price of commodities. The Company's ability to continue with its exploration of the Toni Property is also indirectly subject to commodity prices. The Company is not currently directly exposed to fluctuations in commodity prices as the Company is currently in the exploration phase and has no production.

The recoverability of the Company's investment in World High Life is indirectly tied to the market price of World High Life's common shares. The market price of World High Life's common shares will impact the Company's ability to convert the investment to equity on terms preferable to the Company. Further, the ability of World High Life to raise funds through, equity, debt or operations and effect repayment of the investment from the Company could be impacted by the market price of World High Life common shares. The maximum exposure that could result from adverse changes in the market price of World High Life common shares is the total fair value of the investment at November 30, 2020 of \$1,087,668.

#### Capital management

The Company's objectives when managing capital are to safeguard its ability to continue as a going concern, to pursue the development of its investments and to maintain a flexible capital structure which optimizes the cost of capital within a framework of acceptable risk. In the management of capital, the Company includes the components of shareholders' equity.

The Company manages the capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust its capital structure, the Company may issue new shares, issue new debt, acquire or dispose of assets.

The Company can expect to encounter competition from other entities having similar investment objectives, including institutional investors and strategic investors. These groups may compete for the same investments as the Company, will have a longer operating history and may be better capitalized, have more personnel and have different return targets. As a result, the Company may not be able to compete successfully for investments. In addition, competition for investments may lead to the price of such investments increasing, which may further limit the Company's ability to generate desired returns. There can be no assurance that there will be a sufficient number of suitable investment opportunities available to invest in or that such investments can be made within a reasonable period of time. There can also be no assurance that the Company will be able to identify suitable investment opportunities, acquire them at a reasonable cost or achieve an appropriate rate of return. Identifying attractive opportunities is difficult, highly competitive and involves a high degree of uncertainty. Potential returns from investments will be diminished to the extent that the Company is unable to find and make a sufficient number of investments.

In order to facilitate the management of its capital requirements, the Company prepares annual expenditure budgets that are updated as necessary depending on various factors, including successful capital deployment and general industry conditions.

#### **CHANGES IN DIRECTORS**

On June 29, 2020, Dave Cross resigned as a director of the Company to pursue other opportunities.

On December 21, 2010, the Company announced the appointment of Mr. David Deering, B.Sc. degree in Mining Engineering, to its Board of Directors and to the role of VP Exploration.

#### **CURRENT SHARE DATA**

As at January 19, 2021, the Company has 50,173,415 common shares issued and outstanding.

During nine month period ended November 30, 2020, the Company issued the following shares:

On August 12, 2020, the Company completed a non-brokered private placement of 23,594,665 units at \$0.075 per unit for gross proceeds of \$1,769,600. Each unit consists of one common share and one warrant. Each warrant entitles the holder to purchase one additional share at price of \$0.10 per share, with an expiry date of August 12, 2022. Finder's fees of \$29,815 were incurred. 626,453 finder's warrants (valued at \$85,000 using the Black-Scholes option pricing model) exercisable at a price of \$0.10 until August 12, 2022 were paid and issued in connection with the unit issuance. The fair value of the warrants was recognized as a share issuance cost with a corresponding increase in reserves.

On August 12, 2020, the Company issued 500,000 shares at a fair value \$0.20 for total amount \$100,000 toward the Hammond Reef South option agreement.

On August 27, 2020, the Company completed a non-brokered private placement of 4,973,667 units at \$0.075 per unit for gross proceeds of \$373,025. Each unit consists of one common share and one warrant. Each warrant entitles the holder to purchase one additional share at price of \$0.10 per share, with an expiry date of August 27, 2022. Finder's fees of \$2,340 were incurred. 31,200 finder's warrants (valued at \$2,600 using the Black-Scholes option pricing model) exercisable at a price of \$0.10 until August 27, 2022 were paid and issued in connection with the unit issuance. The fair value of the warrants was recognized as a share issuance cost with a corresponding increase in reserves.

On September 18, 2020, the Company completed a non-brokered private placement of 1,780,000 Flow-Through Share units at \$0.10 per unit for gross proceeds of \$178,000.
