# Planned Strategy to Add New Mental Health Treatments and Collaborate with 3<sup>rd</sup> Party Payors

LOS ANGELES, California, March 24, 2022 / CNW / – Irwin Naturals Inc. (CSE: IWIN) (OTC: IWINF) (FRA: 97X) ("Irwin" or the "Company") announced today its planned suite of clinic services for its chain of psychedelic mental health clinics, Irwin Naturals Emergence.

The Company is in the early stages of a large-scale national rollup of mental health clinics, which will feature treatment with the psychedelic, ketamine, an FDA approved drug used for off-label mental health therapies. The Company intends to expand treatment options at its clinics by offering a broad portfolio of powerful next generation therapies. Irwin Naturals Emergence clinics will be offering three breakthrough treatments to battle America's mental health crisis: (1) ketamine, (2) stellate ganglia block, as aired on by CBS News 60 Minutes June 12, 2019, and (3) transcranial magnetic stimulation (TMS). Offerings may vary by clinic.

Company CEO, Klee Irwin, said, "We believe that, by expanding our offering, we will be able to improve patient success rates. Adding to these three primary treatment pillars, we will be offering talk therapy and breathwork to enhance treatment results."

Irwin continued, "Our goal is two-fold. First, we want to achieve unprecedented levels of clinical effectiveness by combining treatments synergistically. Secondly, we plan to publish this data from our clinics to add to the current understanding of these treatments in the broader scientific community."

Irwin announced it intends to work with major third party payors in order to reduce costs even further, making these life changing treatments accessible to many.

Irwin concluded, "We plan to work with major payors, such as veterans groups and major medical insurance carriers, to adopt policies that include psychedelic-based treatments. Most of these payors are for-profit enterprises interested in reducing medical costs."

## **Regulatory Overview**

The following is a brief summary of regulatory matters concerning ketamine in the United States ("US"). Under the Controlled Substances Act (21 U.S.C. § 811) (the "CSA"), ketamine is currently a Schedule III drug as well as being listed under the associated Narcotic Control Regulations, and psilocybin is currently a Schedule I drug.

Most US States have enacted Controlled Substances Acts ("**State CSAs**") which regulate the possession, use, sale, distribution, and manufacture of specified drugs or categories of drugs and establish penalties for State CSA violations and form the basis for much state and local drug laws enforcement activity. State CSAs have either adopted drug schedules identical or similar to the federal CSA schedules or, in some instances, have incorporated the federal scheduling mechanism. Among other requirements, some US States have established a prescription drug monitoring or review programs collect information about prescription and dispensing of controlled substances for the purposes of monitoring, analysis and education.

In the US, facilities holding or administering controlled substances must be registered with the US Drug Enforcement Agency ("**DEA**") to perform this activity. As such, medical professionals and/or the clinics in which they operate, as applicable, are also required to have a DEA license to obtain and administer ketamine (a "**DEA License**"). While ketamine is a controlled substance in the United States, it is approved for general anesthetic induction under the US Food, Drug, and Cosmetic Act. Once a drug is approved for use, physicians may prescribe that drug for uses that are not described in the product's labelling or that differ from those tested by the manufacturer

and approved by the Food and Drug Administration (the "FDA"). Licensed medical practitioners may prescribe ketamine legally in Canada or the United States where they believe it will be an effective treatment in their professional judgment.
