On March 15, 2019, the Issuer issued by way of private placement 3,000,000 Units (“Units”) at \$0.05 per Unit to Craig Williams. Each Unit is comprised of one common share (a “Share”) and one share purchase warrant (a “Warrant”), exercisable into Shares at an exercisable price of \$0.10 per Share for a period of 24 months.

3,000,000 Shares and 3,000,000 Warrants were issued to Craig Williams on March 15, 2019. The Acquiror's securityholding percentage in the Shares of the Issuer changed from 6.5 % to approximately 7.89%. If the Acquiror were to exercise all of his Warrants, his securityholding percentage in the Shares of the Issuer would change to 10.25%.

The Acquiror acquired control over 3,000,000 Shares and 3,000,000 Warrants

As a result of the foregoing acquisition, the Acquiror now owns 9,000,000 common shares of the Issuer, representing 7.89% of the Issuer's issued and outstanding common shares. Assuming Craig Williams exercises all of his Warrants, he would own 12,000,000 Shares of the Issuer, representing 10.25 % of the Issuer's issued and outstanding shares on partially diluted basis.

The Warrants are exercisable into Shares at \$0.10 per Share.
