Following the Disposition, the Acquiror holds 4,500,000 common shares, which is equal to approximately 10.1% of the issued and outstanding common shares of the Issuer.

The Acquiror disposed ownership and control of 1,500,000 common shares in the capital of the Issuer.

The Acquiror received \$375,000 in exchange for the disposition of 1,500,000 common shares with a deemed value of \$0.25 per common share.

Depending on market conditions and other factors, the Acquiror may acquire additional securities of the Issuer as the Acquiror may deem appropriate, whether in open market purchases, privately negotiated transactions or otherwise. The Acquiror may dispose of some or all of such securities. The Acquiror may also reconsider and change its plans or proposals relating to the foregoing.

This has since changed, and the Acquiror's securityholdings prior to the Disposition were 30,000,000 common shares equating to approximately 13.4% of the issued and outstanding common shares of the Issuer. The foregoing are stated as pre-consolidated figures.
