This report relates to the common shares (“**Shares**”) in the capital of VIP Entertainment Technologies Inc. (“**VIP**”), a corporation with its head office located at 500 4th Avenue SW, Suite 3200, Calgary, Alberta, T2P 2V6.

##### **1.2 State the name of the market in which the transaction or other occurrence that triggered the requirement to file this report took place.**

The transaction that triggered the requirement to file this report was carried out through private transactions and not through any market. The securities of VIP were issued pursuant to a non-brokered private placement (the “**Offering**”) and the Shares are currently listed for trading on the TSX Venture Exchange.

#### **Item 2 – Identity of the Acquiror**

##### **2.1 State the name and address of the acquiror.**

Planet Ventures Inc. (the “**Company**”) has its head office located at 750 West Pender Street, Suite 303, Vancouver, British Columbia, V6C 2T7. The Company was incorporated pursuant to the laws of the Province of Alberta and is a company that is continued and currently existing under the *Business Corporations Act* (British Columbia).

##### **2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.**

On April 3, 2024, the Company acquired 4,000,000 units of VIP (each, a “**Unit**”) at a price of \$0.05 per Unit, for an aggregate purchase price of \$200,000 (the “**Acquisition**”). Each Unit is comprised of one Share and one-half of one Share purchase warrant (each whole warrant, a “**Warrant**”) entitling the holder thereof to acquire one additional Share at a price of \$0.10 for a period of 18 months from the date of issuance.

On April 3, 2024, the Company acquired 4,000,000 Units.

Prior to the Acquisition, the Company did not beneficially own or control any securities of VIP. Following the Acquisition, the Company holds an aggregate of 4,000,000 Units, representing 10.27% of the issued and outstanding Shares on an undiluted basis and 15.41% of the issued and outstanding Shares on a partially diluted basis (based on an aggregate of 38,931,252 Shares issued and outstanding).

The Company acquired ownership of and control over 4,000,000 Units (being, 4,000,000 Shares and 2,000,000 Warrants).
