The Acquiror inherited ownership and control of a convertible debenture exercisable at \$1.00 which could result in the issuance of a total of 1,100,000 common shares plus 10,576,500 common shares due to the settlement of an estate (the "**Transaction**").

The Acquiror inherited ownership and control of a total of 10,576,500 common shares and a convertible debenture convertible into 1,100,000 common shares of the Issuer as a result of the Transaction.

After giving effect to the Transaction, the Acquiror holds approximately 15.2% of the partially diluted outstanding Common Shares.
