4. Summary of Material Change

The Company closed the first tranche of a non-brokered private placement financing (the "**Offering**") through the issuance of 10,555,000 units (each, a "**Unit**") at a price of \$0.125 per Unit for gross proceeds of \$1,319,375.

5. **Full Description of Material Change**

The Company closed the first tranche of a non-brokered private placement financing through the issuance of 10,555,000 Units at a price of \$0.125 per Unit for gross proceeds of \$1,319,375

Each Unit is comprised of: (i) one common share in the capital of the Company (each a "**Common Share**"); and (ii) one Common Share purchase warrant (each, a "**Warrant**"). Each Warrant entitles the holder to purchase one additional Common Share at an exercise price of \$0.15 on or before September 20, 2024.

Gross proceeds raised from the Offering will be used for working capital and general corporate purposes. The securities issued upon closing of the Offering are subject to a hold period until July 21, 2023, pursuant to applicable securities laws.

Certain eligible persons (the "**Finders**") were paid finder's fees 210,000 Units representing cash commission in the amount of \$26,250.

In connection with the Offering, an aggregate of 1,384,000 Units were acquired by insiders of the Company.

A portion of the Offering constituted a "related party transaction" as defined in MI 61-101 as insiders of the Company subscribed for an aggregate of 1,384,000 Units under the Offering. Such related party transactions are exempt from the formal valuation and minority shareholder approval requirements of MI 61-101 as neither the fair market value of securities being issued to the related parties nor the consideration being paid by any of the related parties exceeded 25% of the Company's market capitalization. The participants in the Offering and the extent of such participation were not finalized until shortly prior to the completion of the Offering. Accordingly, it was not possible to publicly disclose details of the nature and extent of related party participation in the Offering pursuant to a material change report filed at least 21 days prior to the completion of the Offering.
